Contextually, we are joined in the urban neighborhood by Congregations from the Lutheran (ELCA), Methodist, Baptist, Presbyterian, Episcopalian, Coptic Orthodox, and 2 other Catholic congregations. In addition, we have Interfaith relationships with the neighborhood Synagogue, the Buddhist Sangha, the Unitarian Universalist Society, the Quakers and the Southern California Islamic Center. We are an integral part of the religious and civic fabric of our neighborhood and city.

**When Dancing turns to Mourning:  
Worshipping God in the Face of Violence  
Yale Institute of Sacred Music  
June 13-15, 2017

Saint Monica has been faced with a number of tragic events over the past several years. Our community's response to these tragedies has been comprehensive through worship, pastoral care and follow up with the community. In the face of a mass shooting at Santa Monica College in 2013, our community not only reached out to the families of the victims, but to the community of first responders, and the college itself. Our pastor was called to pray with the family of the shooter because no other minister would come to pray with them. One year after, we brought the community together for a healing mass in remembrance, which brought healing and peace to many. It was hosted by the tri-parish Catholic communities of Santa Monica, but was an interfaith celebration involving clergy from Islam, Judaism and Catholic faiths. The focus of the celebration was compassion and forgiveness in the face of tragedy. (Printed materials)

Our community held a vigil on gun violence as an ecumenical outreach that called together families of gun violence victims. The ringing of the bell was a call to action as each person killed was remembered with a short reflection. The families provided materials for the creation of posters that called to mind the victims and their lives cut short. (Printed materials)

After the Orlando mass shooting in June 2016, our community prepared a prayer vigil, which included a video of pictures of all of the victims. It was live streamed and prepared by our worship and music staff along with members of our gay and lesbian ministry outreach. It brought healing and comfort to our community who felt deeply wounded by the tragedy.

We pause to consider how we can help end this epidemic of violence and bring peace to our city, our neighborhoods and our country. Gun violence has become a public health epidemic. When it is impossible for us to find peace, we turn to our Lord, the Prince of Peace to show us the way. God calls us to be makers of peace as sons and daughters of God.

As the name of each victim is called, the bell will ring once in memory, ... the bell calls us together, it calls us to action, it calls us in joy and it calls us in sorrow.

*Names are read with the bell ringing after each name.*

**Presider:** Grant, O God, that we lie down in peace, and raise us up, our Guardian, to life renewed.

Spread over us the shelter of your peace. Guide us with Your good counsel; for your Name's sake, be our help. Shield and shelter us beneath the shadow of Your wings. Defend us against enemies, illness, war, famine and sorrow. Distance us from wrongdoing. For you, God, watch over us and deliver us. For you, God, are gracious and merciful. # Keeping Gun Violence Prevention on the Front Burner: What You Can Do

**ACTIVISM COMES IN ALL SHAPES AND SIZES.**

**FIND WHAT IS RIGHT FOR YOU AND COMMIT TO DOING SOMETHING TODAY!**

**STORE** guns safely: unloaded and locked, with the ammunition locked separately. Hiding guns from kids is not enough and telling them not to touch guns is not enough. A three year old child has the strength to pull a trigger. (1) It is the gun owner's responsibility to ensure that the gun does not pose a hazard to others, and, in California, an adult is criminally liable if a child gains access to his/her gun. (2)

**REMOVE** unwanted guns from your home to protect against misuse and theft. Most gun suicides are committed at home using the family gun. (3) Contact your local Police Department for the proper procedure to turn in unwanted guns.

**ASK** if there are guns at the homes where the children in your care visit. If there are, then make sure they are safely stored. Visit [askingsaveskids.org](http://askingsaveskids.org) for more information. About 40% of homes with children have guns, and many are loaded and unlocked. (4)

**LEARN** the facts about guns and gun violence. The US leads the world in civilian gun ownership, (5) but all those guns don't make us safer. Guns injure or kill 100,000 people in the US every year, (6) and the gun death rate in the US is higher than all other industrialized nations. (7)

**SHARE** information about guns and gun violence with your family, friends, colleagues, and social networks. Provide information and resources to those who are in a position to influence others such as health care providers, mental health providers, faith groups, educators, librarians, **Democratic clubs** and civic groups. **Invite one of our Chapter speakers to your next meeting to give a free presentation.**

**TELL** your elected officials that you support legislation to strengthen state and federal gun laws. Contact them by telephone, letter or email or by a personal visit. Contact them repeatedly at both their district and state/federal offices to voice your position. Attend Town Hall meetings. Keep the issue and your expectations before your elected officials. **Be sure to thank them when they support common sense gun laws because they will be receiving many negative comments from pro-gun activists.**

**SUPPORT** gun violence prevention advocacy groups with your time and/or money.

**WRITE** letters to the editor of your local paper. ([letters@latimes.com](mailto:letters@latimes.com)).

**VOLUNTEER** in election years to campaign for a candidate of your choice.

**CELEBRATE** and build on incremental successes. Gun violence prevention activists just like you got involved and made a difference! California has the strongest gun laws in the nation. Between 1990 and 2010, California reduced its firearm mortality rate by 52 % - 24 percentage points better than in the rest of the nation. (8)
